Candidate Statements and Photographs

Candidates may submit a statement and passport sized photograph to be included with ballot material. Only statements and photographs which comply with the Rules and are received by the Returning Officer with the candidate's nomination form not later than 12 noon AEST on 29/06/2018 can be accepted. Statements and photographs are preferred in Word and jpeg format respectively.

Voting Period

The ballot, if required, will open on 31/08/2018 and close at 10am AEST on 27/09/2018.

Scrutineers

The appointment of scrutineers opens on 15/06/2018 and closes 12 noon AEST 29/06/2018. A form is available from the Returning Officer for the purpose of appointing a Scrutineer.
