*NOTE 2: Additional public holidays: When a public holiday falls on a weekend, penalty rates cannot be claimed for both the public holiday and the additional public holiday (e.g. cannot claim for 25/12 Christmas and 27/12 additional public holiday for Christmas). Staff who work both days will only be paid public holiday rates on one of the days.
